Indeed, the first contribution is a remarkable (and unique) paper, bringing together the work of some 8-9 internationally recognised scientists to tell the story and show the relevance to the present day of the Sahara past climates etc. Nearly all the contributions stand in their own right at the cutting edge of research in their respective fields

(e.g. archaeology, history, politics, etc.). This book was previously published as a special issue of the Journal of North African Studies.

Controlling the Past, Owning the Future - Ran Boytner 2010-12-15

What are the political usesÑand misusesÑof archaeology in the Middle East? Heritage Futures - Rodney Harrison 2020-07-28

Preservation of natural and cultural heritage is often said to be something that is done for the future, or on behalf of future generations, but the precise relationship of such practices to the future is rarely reflected upon. Heritage Futures draws on research undertaken over four years by an interdisciplinary, international team of 16 researchers and more than 25 partner organisations to explore the role of heritage and heritage-like practices in building future worlds. Engaging broad themes such as diversity, transformation, profusion and uncertainty, Heritage Futures aims to understand how a range of conservation and preservation practices across a number of countries assemble and resource different kinds of futures, and the possibilities that emerge from such collaborative research for alternative approaches to heritage in the Anthropocene. Ideologies in Archaeology - Reinhard Bernbeck 2011-11-01

In addition to situating this volume in a wider history of archaeological currents, Demoule identifies the institutional and cultural factors that may account for the current direction in North American archaeology.
