After Alexander's death he crushed a Greek uprising and became regent of the co-kings, Alexander's mentally impaired half-brother (Philip III Arrhideus) and infant son (Alexander IV). He brokered a settlement between the contending Successors but died in 319 BC, having first appointed Polyperchon to succeed as regent in preference to his own sons. Antipater's eldest son Cassander later became regent of Macedon but eventually had Alexander IV killed and made himself king. Three of his sons in turn briefly succeeded him but could not retain the throne. Antipater's female heirs are shown to be just as important, both as pawns and surprisingly independent players in this Macedonian game of thrones. The saga ends with the failed bid by Nikaia, the widow of Antipater's great grandson Alexander of Corinth, to

63BC and partitioned the kingdom. The last chapters consider the continued Jewish resistance to Roman rule and factional fighting, until the crowning of Herod, marked the end of the Hasmonean dynasty.

The Galatians - John D. Grainger 2020-08-30

A historian of the ancient world examines the epic rise and fall of the Celtic tribes who invaded the Mediterranean and lands further east. it. Although sometimes presented as a failure against the unstoppable might of Rome, Antiochus III must rank as one of the most energetic and effective rulers of the ancient world. This book narrates his eventful career—and examines Seleucid military organization and royal administration.

His most famous achievement was his victory against immense odds at the land battle of Tigranocerta. We are also reminded that he one of the most formidable naval strategists of the Roman Republic. Lucullus complicated relationship with Sulla and Crassus is explored and the study concludes with the retirement of the man Pliny the Elder memorably referred to as 'Xerxes in a Toga', a patron of the arts and master of a life of horticulture and reflection.

Charles II led a desperate counter-invasion over the border, hoping to raise a royalist rebellion and forcing Cromwell to follow him, though he left Monck to complete the pacification of Scotland. Cromwell caught up with Charles II at Worcester, where the Scots/Royalist army was decisively defeated and destroyed, thousands of the prisoners being sold into slavery in the West Indies and the American colonies. This revised and updated edition contains an expanded chapter

on the aftermath of the war and the fate of the POWs, drawing on major new archaeological evidence, as well as an expanded Conclusion.
