Myth and Memory in the Construction of Community - Bo Stråth 2000

Across and beyond Europe, history is being rewritten in the wake of the Cold War's dissolution. An example of this process is the re-evaluation of the part played by resistance movements during World War II in country after country. This book deals with the role of myth and memory in the formation of collective identities with a particular emphasis on national identities. Myth and memory should not be seen as clearly demarcated from history. They are history in ceaseless transformation and reconstruction, the image of the past is continuously reconsidered and reconstituted in the light of an everchanging present. History is an interpretation of the past; not the past as it really was. The key question of this book concerns the role myth and memory play in the construction of communities, and what the distinction between collective myth and memory signifies. The discussion of this question is undertaken in theoretically oriented chapters as well as 15 case studies of national patterns from Scandinavia in the north to Italy and Israel in the south, and from the USA in the west to Russia in the east, as well as local community constructions in working-class districts in Glasgow and Roubaix and the national politics of architecture in Berlin and Rome. This book appears within the framework of a research project on the cultural construction of community in modernisation processes in comparison. This project is a joint enterprise of

the European University Institute in Florence and the Humboldt University in Berlin sponsored by the Bank of Sweden Tercentenary Fund.

This book, first published in 1999, studies and compares two sixteenth-century libraries. Jean Grolier's was a bibliophilic 'cabinet' of fine books; Diego Hurtado de Mendoza's was a much larger and more scholarly collection; a full catalogue is provided for the first time. Both men were greatly influenced by experience of Italy. Grolier has been called 'the Prince of Bibliophiles'; the books he commissioned have long been famous. This is the first full account of his life for eighty years. Hurtado de Mendoza was a poet, historian, Greek scholar and Arabist. He served as the Emperor's Ambassador in Venice (1540-6), to the Council of Trent (1545-6), and to the Pope (1547-52). In Venice he set out to form for Spain a collection of Greek manuscripts to rival that being formed for France by Francis I's agents. Anthony Hobson's text is complemented by ninety-one illustrations, several thematic indexes, eleven appendices and a bibliography.

Bruxelles, Bern, Berlin, Frankfurt/M., New York, Oxford, Wien. This book contributes to the debate on what Europe is by demonstrating the complexities and contradictions inherent in the concept. They are seen most clearly when Europe is viewed from a long historical perspective. During the closing decades of the twentieth century Europe emerged as one of the main points of reference in both the cultural and the political constructs of the global community. An obsession with the concept of European identity is identifiable. European identity is usually seen in relation to national identity, either in an uneasy opposition to it, that is, as an alternative to the nation, or in a situation in which it overlaps with and complements the nation. The structure of national identity is projected onto European identity, and this projection has an ideological underpinning, for no projection is ever non-interested or non-ideological. This process of identity construction provokes searching questions which the book aims to address. At the same time the book explores the opportunities offered by the concept of Europe to see how it may be used in the construction of the future. The approach is one of both deconstruction and reconstruction. The issue of Europe is closely related in the book to more general issues relating to the cultural construction of community. The book should therefore be seen as the companion of *Myth and Memory in the Construction of Community*, which also is published by PIE-Peter Lang in the series *Multiple Europes*.

Recent publications indicate that there is a great need for people writing on the subject to be aware of material which is not in their mother tongue: approaches presented as 'new' are in fact merely 'contemporary', and have been discussed or practiced in other centuries and countries. Just as knowledge of practices and effects of art conservation and restoration should form an integral part of History of Art Degrees, the more theoretic, abstract and historical aspects, should also be part of the training. This book is an

invaluable source for academic and public institutions, art historians as well as practicing conservators and lovers of art.
